# What is the FACES Benefits Estimator ?

---

An extension of OPM's internal annuity computation system that is used to compute retirement annuities and death claims.



# What will the Benefits Estimator compute?

CSRS and FERS retirement estimates for:

- Voluntary
- Early Out
- Discontinued
- Disability
- Deferred



# What will the Benefits Estimator compute?

- Projected Annuity Estimates
- FERS Annuity Supplement
- Deposit and Redeposit Options (deposit amount and interest through the present date)
- CSRS survivor partial options
- CSRS Offset
- Windfall Elimination
- Cost of Health Benefits and Life Insurance premiums
- Retirement Service Computation Dates
- Post-56 Military deposit interest calculations

Our computer data base is updated with the latest legislative and health and life insurance premium changes. Software updates to all users are automatic.



# FACES Assets

- FACES is available to all Federal Agencies
- FACES is Free
- FACES is hosted on an unpublished OPM WEB Server – we will provide the WEB address (URL)



# FACES Requirements

- Internet access (Microsoft Internet Explorer - 5.5 or higher)
- Java Script active
- Training to ensure proper use
- You must have an OPM assigned User ID and password
- FACES users must be trained Retirement Benefits Counselors (target audience)
